Actively Managed

Actively managed ETFs combine the benefits of traditional asset management expertise and stock selection with the structural benefits of ETFs, such as improved liquidity, transparency and cost-effectiveness.

Smart-Beta

First Asset Smart Beta ETFs employ factor and multi-factor based investment methodologies. Factor-based investing is backed by extensive empirical evidence derived from comprehensive historical analysis supporting the theory that factors such as a company's value, momentum or size result in positive risk-adjusted performance. Factor-based indexing allows for a tilt on portfolios toward one or more important factors in an effort to deliver stronger risk-adjusted returns than more traditional, capitalization-weighted indices.

Covered Call

A covered call option strategy is implemented by selling a call option contract while owning an equivalent number of shares of the underlying stock resulting in a systematic equal weighting. This is generally considered to be a conservative strategy because it decreases the risk associated with stock ownership, while providing additional income over and above the dividend income from the underlying stocks.
